KERALA STATE-LEVEL SELECTION TRIALS – 2026

SPECIAL CHILDREN (INTELLECTUAL DISABILITY CATEGORY)

For the 64th National Roller Skating Championship – 2026, Karnataka

The Kerala Roller Skating Association (KRSA) hereby announces the State-Level Selection Trials for Special Children to select the Kerala team for the upcoming 64th National Roller Skating Championship – 2026, Karnataka.

The trials will be conducted as follows:

Date: 21st September 2026 (Monday)

Venue: AISSA, Panikkarambalam, Perumbavoor, Kerala

Registration: 1:00 PM onwards

Event Reporting: 3:00 PM

I. SPEED SKATING TRIALS: The selection trials will consist of two Speed Skating races:

A. Inline Skating - For Inline skaters only.

B. Quad Skating - For Quad skaters only.

Important: Inline skaters are not permitted to participate in Quad events, and Quad skaters are not permitted to participate in Inline events.

ii. AGE GROUPS & RACE DISTANCES : Separate events will be conducted for Boys/Men and Girls/Women.

Age Category	Trial Events
6–8 Years	1 Lap + D Race / 2 Lap + D Race
8–10 Years	1 Lap + D Race / 2 Lap + D Race
10–12 Years	1 Lap + D Race / 500M + D Race
12–15 Years	1 Lap + D Race / 500M + D Race
15–18 Years	1 Lap + D Race / 500M + D Race
Above 18 Years	1 Lap + D Race / 500M + D Race

Maximum participation: Each skater may participate in two races only.

III. REGISTRATION : All entries must be submitted online through the official KRSA Website.

registration portal: rollersportskerala.org

No offline entries will be accepted. Participants are advised to complete the registration carefully and ensure that all information is accurate and matches the supporting documents.

VI. DOCUMENTS REQUIRED FOR VERIFICATION: Every participant must produce the following documents at the time of registration/verification:

1. e-Aadhaar-As proof of Date of Birth.

2. Disability Certificate / UDID Card Issued by the competent Government authority.

3. RSFI Annual Skater Registration – 2026–27 Valid registration is mandatory.

The Aadhaar used for the selection trial must be the same Aadhaar used for RSFI Annual Skater Registration. The Date of Birth and other particulars must match the participant's official school/college records.

The Aadhaar should be available in English or Hindi. The original Aadhaar/document must be produced whenever required for verification.

V. DISABILITY ELIGIBILITY: The Disability Certificate must be issued by: A District/State Medical Board consisting of Government doctors, or Through a valid UDID Card issued by the Government of India.

The document must clearly specify the eligible disability, such as: Intellectual Disability/ Autism Spectrum Disorder/Mental Illness. The disability percentage must be **50% or above**.

VI. No entry fee will be charged for participation in the Special Children category. However, RSFI Annual Skater Registration for 2026–27 is compulsory for all participants.

VII. SELECTION TO NATIONAL CHAMPIONSHIP : Following the completion of the State-Level Selection Trials, up to two (2) eligible skaters in each category/event may be selected to represent Kerala at the 64th National Roller Skating Championship – 2026.

Selection will be based on performance in the State Selection Trials and shall be subject to document verification, eligibility requirements and applicable RSFI rules and regulations.

VIII. All participating skaters must be registered members of their respective District Roller Skating Association and must have valid insurance coverage, either through the Association or through an individual personal accident insurance policy

IX. IMPORTANT NOTICE

Parents, guardians, skaters and District Roller Skating Associations are requested to ensure that all eligibility requirements and documents are completed before registration.

KRSA reserves the right to verify documents and eligibility at any stage. Entries with incorrect, incomplete, mismatched or invalid documents may be rejected.

All affiliated District Roller Skating Associations are requested to circulate this Circular among eligible Special Children skaters and encourage their participation.
